

Terms and Conditions

- Participation in the program requires consent from the building owner, the condo board, or an authorized representative with the legal signing authority for the eligible building.
- Efficiency Nova Scotia may at its sole discretion, approve or reject any rebate at any time.
- A business can apply for rebates at multiple sites, but it is limited to a maximum of \$80,000 in total rebates from the EV Ready Approach and/or the Standalone EV Charger program in a calendar year.
- The Efficiency Nova Scotia rebate may be stacked with funding from other organizations; Efficiency
 Nova Scotia reserves the right to limit its rebate amount such that the total combined rebate from all
 funding sources does not exceed 100% of the project costs. Program participants are responsible for
 ensuring their eligibility and registration of other programs.
- Receiving Pre-Approval does not alone guarantee the applicant of a rebate, additional program requirements and Terms and Conditions must be met.
- Pre-Approval from Efficiency Nova Scotia is required prior to the applicant incurring costs for consulting
 or contractor services or purchasing and installation of eligible products. Eligible project costs incurred
 by the applicant prior to receiving Pre-Approval may not be eligible for rebates.
- Applicants should allow up to 30 days for their Pre-Approval application to be reviewed by Efficiency Nova Scotia.
- Applicants must complete projects and submit their Rebate Form within six (6) months from receiving Pre-Approval from Efficiency Nova Scotia.
- Applicants should allow up to 60 days for delivery of payment from submitting their Rebate Form.
- Submitting program forms with incomplete or missing information will delay Efficiency Nova Scotia in providing approval and/or payment.





- It is the applicant's responsibility to obtain any and all relevant permits required for work, construction
 and installation of equipment related to the project, and to choose a qualified installation professional
 or contractor who maintains the required certifications necessary to safely complete the said work,
 construction, and installation.
- It is the applicant's responsibility to ensure that work completed by its consultants and contractors (consulting work, studies, plans, designs, equipment purchase and installations, etc.) fully complies with the rebate program requirements and program Terms and Conditions.
- Efficiency Nova Scotia is not responsible for any losses that the applicant incurs as a result of applicant's failure to fully comply with the eligibility criteria that are associated with this rebate program.
- Efficiency Nova Scotia reserves the right to request proof of electrical inspection.
- Applicant must provide detailed quotes and invoices that include itemized breakdown with number of units, manufacturer, model or part number, separated labour costs, purchase date, and name and address of product vendor or service provider.
- Efficiency Nova Scotia reserves the right to verify sales transactions listed on submitted invoices.

 electrical utility, and/or Nova Scotia Power, are not responsible for the accuracy or validity of any

 to confirm rebate eligibility and not to verify that that the applicable technical requirements of the
 installation have been met.
